**This cause coming on for disposition** pursuant to the defendant's  plea  stipulation as to the facts supporting the charge of \_\_\_\_\_ and the court having considered the statement of the prosecuting attorney, the Court finds that the defendant has agreed and the defendant shall obey all of the conditions imposed by the order of Supervision:

- a. Imprisonment is not necessary for the protection of the public.
- b. That the defendant is not in need of correctional treatment that can most effectively be provided by a sentence of imprisonment; or
- c. Court Supervision would not deprecate the seriousness of the defendant's conduct and would not be inconsistent with the ends of justice;
- d. That the defendant is not likely to commit further crimes;
- e. That the Defendant and the Public would best be served if the defendant were not to receive a criminal record;
- f. That in the best interest of justice an Order of Supervision is more appropriate than a sentence otherwise permitted under the code.

Case #'s \_\_\_\_\_ are dismissed pursuant to this agreement.

**IT IS HEREBY ORDERED THAT**

The defendant shall be placed on a period of Court Supervision until \_\_\_\_\_, 20\_\_\_\_ and further proceedings and the entry of judgment of conviction shall be deferred until the conclusion of that time. **THE DEFENDANT SHALL:**

- Not violate any statute of any jurisdiction.
- Appear before the court at such times as the court shall direct, by written notice or otherwise.
- Report to Pretrial services /Probation office when directed by that office.
- Inform the Clerk of the Circuit Court of a change of address within 24 hours.
- Complete:  4 hour Traffic Safety School Program;  8 hour Traffic Safety School Program;  Attitudinal Dynamic Program
- Perform \_\_\_\_\_ hours of community/public service at times and places designated or permitted by the Probation Department.
- Other: \_\_\_\_\_
- Appear in Court on: \_\_\_\_\_, 20\_\_\_\_ at \_\_\_\_\_ in Courtroom 125 for status on Compliance with this order.

**FURTHER THE COURT ORDERS:**

1. That the Court shall retain jurisdiction of the charges herein until the conclusion of the above period of supervision.
2. That if during the period of supervision, the defendant violates any of his conditions of supervision, the Court after hearing, may revoke such Supervision, enter judgment of conviction, and impose sentence as provided by law. Judgment for any traffic related charges may also be reported to the Office of the Illinois Secretary of State.
3. That if the Court determines at the conclusion of said period of supervision that the defendant has successfully completed all conditions of supervision, the Court shall discharge the defendant and dismiss the charges.
4. That said discharge and dismissal upon successful conclusion of the period of supervision shall be deemed without adjudication of guilt and shall not be termed a conviction for the purpose of disqualification or disability imposed by Illinois law on a conviction of a crime.
5. In addition to any other sentences imposed in the case, the Defendant is ordered to pay the following fines, fees, and assessments:
6. **P.A. 100-0987** (eff. July 1, 2019) established a minimum fine of \$25 for a minor traffic offense and \$75 for any other offense, unless otherwise provided by law. If applicable, Defendant has been admonished of the right to elect whether to be sentenced under the law in effect at the time of the offense or at the time of sentencing.
