## TRAFFIC COURT GUILTY PLEA AND SENTENCING DATE ORDER

- 2. I know I have the right to a trial by a jury or to a trial before a judge without a jury, whichever I choose. That the state has the burden of proving me guilty beyond a reasonable doubt in a trial and that I do not have to prove my innocence. That by entering this guilty plea there will not be a trial of any kind.
- 3. I know I have the right to remain silent and not plead guilty and that I am giving up this right.

- 5. I know I have the right to present witnesses in my defense and to compel the attendance of any witness refusing to attend on my behalf and that I am giving up this right.
- 6. I know I have the right to an attorney and that if I cannot afford one the court will appoint an attorney to represent me through all stages of my criminal charge(s).
- 7. No one has threatened or coerced me into pleading guilty, and that I am pleading guilty voluntarily and of my own free will.
- 8. I admit the state could prove the elements of my charge(s) at a trial.
- 9. I am not under the influence of any kind of alcohol, drugs or narcotics.
