**ORDER/WRIT**

**THE COURT HAS REVIEWED THE CURRENT CONDITIONS OF RELEASE AND FINDS THAT:**

- (Continued detention)** The Court finds that continued detention is necessary to avoid a real and present threat to the safety of any person(s) or the community, based on the specific articulable facts of the case, or prevent the defendant's willful flight from prosecution. 725 ILCS 5/110-6.1(i-5).
- (Release from custody)** The Court finds that continued pretrial detention is no longer necessary and orders that the defendant shall be released from custody with appropriate conditions of release as reflected in the Conditions of Release Order filed instanter.
- (Out of custody/conditions unchanged)** The current conditions imposed continue to be necessary to reasonably ensure the defendant's appearance as required, the safety of any other person and the defendant's compliance with all the conditions of pretrial release. 725 ILCS 5/110-5(f-5).
- (Out of custody/modify conditions)** The defendant's conditions of release shall be modified as reflected in the Conditions of Release Order filed instanter.

**THE COURT FURTHER ORDERS THAT:**

- Pretrial services shall complete a pretrial services report. The Clerk's office shall give notice of this order to Pretrial.
- Defendant shall be held until released directly to  Pretrial Services  Probation.
- Defendant shall be **released** from custody on the charges listed in this order due to:
  - Plea to time served;  Case dismissed;  Found not guilty;  Other \_\_\_\_\_
