**SANCTIONS ORDER**

1. The State filed a verified Petition for Sanctions on \_\_\_\_\_, pursuant to 725 ILCS 5/110-6(d).
2. Following a hearing on the state’s petition at which the defendant was present,  represented by counsel  waived his right to counsel, had the opportunity to be heard and present evidence in mitigation,
  - The Court does not find by clear and convincing evidence that the defendant violated the terms and conditions of his or her pretrial release. No sanction shall be imposed. (*skip to Next Court Appearance*)
  - The Court finds by clear and convincing evidence that:
    - a. The defendant committed an act that violated a term of the defendant’s pretrial release;
    - b. The defendant had actual knowledge that the defendant’s action would violate a court order;
    - c. The violation of the court order was willful; and
    - d. The violation was not caused by a lack of access to financial monetary resources.
3. As a sanction for violating the conditions of pretrial release, **IT IS HEREBY ORDERED** that:
  - The defendant receive a verbal or written reprimand from the court.
  - The defendant serve \_\_\_\_\_ days in the Winnebago County Jail (up to 30). Defendant’s sanction shall begin  instanter  on \_\_\_\_\_ at which time the defendant shall surrender to the Winnebago County Jail, 650 W. State Street, no later than \_\_\_\_\_ AM/PM.  Day for day credit does not apply.
  - The defendant’s pretrial release conditions are modified as reflected in the amended conditions of pretrial release order filed instanter.
